6. The right granted by this letter is non-exclusive. All rights of every nature not expressly granted herein are reserved by Gullane;

8. There is no fee for the right granted herein;
9. Gullane warrants only that it has the legal right to grant the consent set forth herein, and this consent is accepted by you and the Browns without other warranty or recourse against Gullane, its successors or assigns; and
10. You and the Browns shall indemnify and hold Gullane harmless from all damages, costs and expenses, including reasonable attorneys' fees, arising out of or in connection with the use of the Artwork in a manner or form not authorized herein.
